From The President


-A vote was taken on the inclusion of digital imaging into the regular competition categories. The club has voted to allow digital images to be included. The proposal from the board (as printed in the April newsletter) reads: "The HPS Board recommends that for the remainder of 1999 any prints or slides produced digitally should be entered in one of the three appropriate existing competition categories; B&W, color print or slide. The original image and any modifications of the original image must be made by the entrant. Also the original image must be from a camera, digital or conventional." If you have any questions concerning the eligibility of your entrees contact Barbara Staggs.

-For some of our program meetings this year we are considering a number of educational slide programs put out by the Photographic Society of America. The topics and descriptions sound intriguing so I hope that these programs will be a big help in advancing member's techniques.

-REVIEW OF SOME COMPETITION RULES

All of you should have a list of competition rules. If you need a set please contact Barbara Staggs by email, phone or at the next meeting. Meanwhile here are a few things to consider.

The photos need to be at least 5x7 and must be matted. Remember that the judge can be influenced



by the way your photo is presented. Please do not have exposed tape or anything else on the back which could possibly damage another photo that might be placed against it.

You may submit a maximum of 6 photos but only 4 in one category.

You must be a current dues paying member. Be sure to put your name on the back and indicate which way the picture is to be shown by writing "top" or drawing an arrow.

NOTE: The rules say that entries must be submitted no later than five minutes after the time the meeting is scheduled to begin. We have been rather lax in this. However with the greater number of entries that we have been receiving we will enforce this rule.

Time Inc. has just issued a new assignment contract that grants the company broad rights to reuse assignment photos--even outtakes--in foreign editions. Photographers and photo agents have responded with sharp criticism. As one photo agent says, "We're at a point where unless we take a stand [against giving up re-sale rights], there will be no agencies anymore."
